Purpose of This Report

The purpose of this report is to recognize those Indiana high schools that have excelled academically while providing the greatest value for Hoosier tax dollars. Each of these schools excelled with comparatively less funding. Many of these schools also excelled with comparatively high percentages of low income students.

Using ISTEP+ pass rates, ISTEP+ Pass+ rates, adjusted graduation rates, SAT participation rates and average composite scores, and Advanced Placement participation rates and passing scores, the Indiana Chamber of Commerce developed a school performance rating for each high school. This rating is called the school's Quality Index (QI). The QI was then compared to each school's total revenues per pupil to identify the state's Best Buys. Among those schools identified as Best Buys, we also reviewed their participation in the federal free/reduced lunch program and those Best Buy schools with participation rates above the state median were awarded our Honor Roll designation.

The goal of the *Indiana's Best Buys* report is to celebrate excellence and encourage improvement. Indiana high schools have the necessary resources to rank among the best in the world. However, to be the best, everyone must work at continuously analyzing, reforming and/or maintaining quality instructional programs. Parents, teachers, families, friends, businesses and students must collectively commit to seeking success for their schools. It is our desire to provide schools and their communities with information and a comparative analysis of their current educational environment to help them set goals that are demonstrably achievable.

Definitions of Factors and Methodology

ISTEP+ (Fall 2008)

The ISTEP+ (Indiana Statewide Testing for Educational Progress) has been given to students in grades three through 10, but the scores shown in this report include only the 10th grade test, which also is known as the Graduation Qualifying Exam (GQE). Through the class of 2011, the GQE will be required for high school graduation, unless the student receives a specified waiver. Beginning with the class of 2012, students will be required to pass end-of-course exams; therefore, the September 2008 GQE was the last statewide administration of the exam and, accordingly, this will be the last time that GQE scores are used in the Best Buys analysis.

The scores presented in this report are the percentages of students passing both the language arts and mathematics portions of the GQE that was administered in September 2008, the latest results available. The ISTEP+ scores were used because they reflect the school district's overall effectiveness in equipping students with basic knowledge of the fundamentals. We also have included the percentage of 10th grade students achieving the state's Pass+ designation in either language arts or mathematics. Students reaching this level on the ISTEP+ are considered by the state to have demonstrated exemplary performance on the

state's academic standards. The inclusion of this measure helps recognize schools that are encouraging higher levels of achievement, in addition to the minimum achievement expectations that are reflected in the standard pass rates for ISTEP+.

Scholastic Aptitude Test (SAT) (2008-09)

This report includes both the composite scores and the participation percentages for the Scholastic Aptitude Test (SAT). The SAT is taken primarily by seniors in high school, with some junior and sophomore participation. The SAT composite score was included in this report because it is the primary tool used in Indiana to measure college readiness. Preparation for college is an increasingly important goal for our schools given the estimates that 80% of future jobs will require some college education. It is particularly important in Indiana, where the percentage of adults with college degrees ranks among the lowest in the country.

This report also includes the percentage of 12th grade students in each high school who took the SAT during the 2008-09 school year. This factor is included to account for the widely different participation rates of students taking the SAT and to recognize schools that have large percentages of student participation.

Adjusted Graduation Rate (2007-08)

Indiana’s high school graduation rate has undergone a legislatively-mandated overhaul that state and national experts consider to be more reflective of actual graduation rates than has been reported previously. This report includes graduation rates because they reflect a school’s ability to retain students and to assist their students in meeting state standards for high school graduation. These rates have been adjusted to net out schools’ use of ISTEP+ waivers that, at some schools, has been considered excessive. For this report, we have reduced each school’s reported graduation rate by the percentage of graduates receiving waivers that is greater than the state’s median waiver rate of 5.8%. (For example, a school granting waivers to 7.3% of their students would have their reported graduation rate reduced by 1.5%.) Given the critical importance of competence-based learning, we are especially concerned that Indiana’s median waiver rate has been increasing steadily, up from 3.9% for the class of 2006 and 5.0% for the class of 2007. We also remain concerned that the state’s mandatory audit process has not yet produced transparent results. Despite these ongoing concerns, we consider the high school graduation rates to be one of the most important issues facing our state and have therefore weighted the use of these rates accordingly.

Advanced Placement (2008-09)

Advanced Placement (AP) exams are nationally administered tests that measure a student’s preparation for specific college-level courses. Students achieving a score of three, four or five on an AP exam may receive college credit for the subject of that respective exam. AP data are included in this report to recognize schools that are best preparing students for college-level coursework. We have included AP data by multiplying the percentage of 11th and 12th grade students achieving threes, fours or fives times the number of AP tests administered and dividing that product by the number of 11th and 12th graders in the school. Given that some individual students take multiple AP exams while other students take none, this calculation does not produce a precise passing rate per student, but it does provide a comparable index of AP pass rates for each school.

At-risk Students – Free/Reduced Lunch Participation (2008-09)

Schools that perform at comparatively high academic levels with relatively limited funding and adverse demographic factors are recognized as Honor Roll

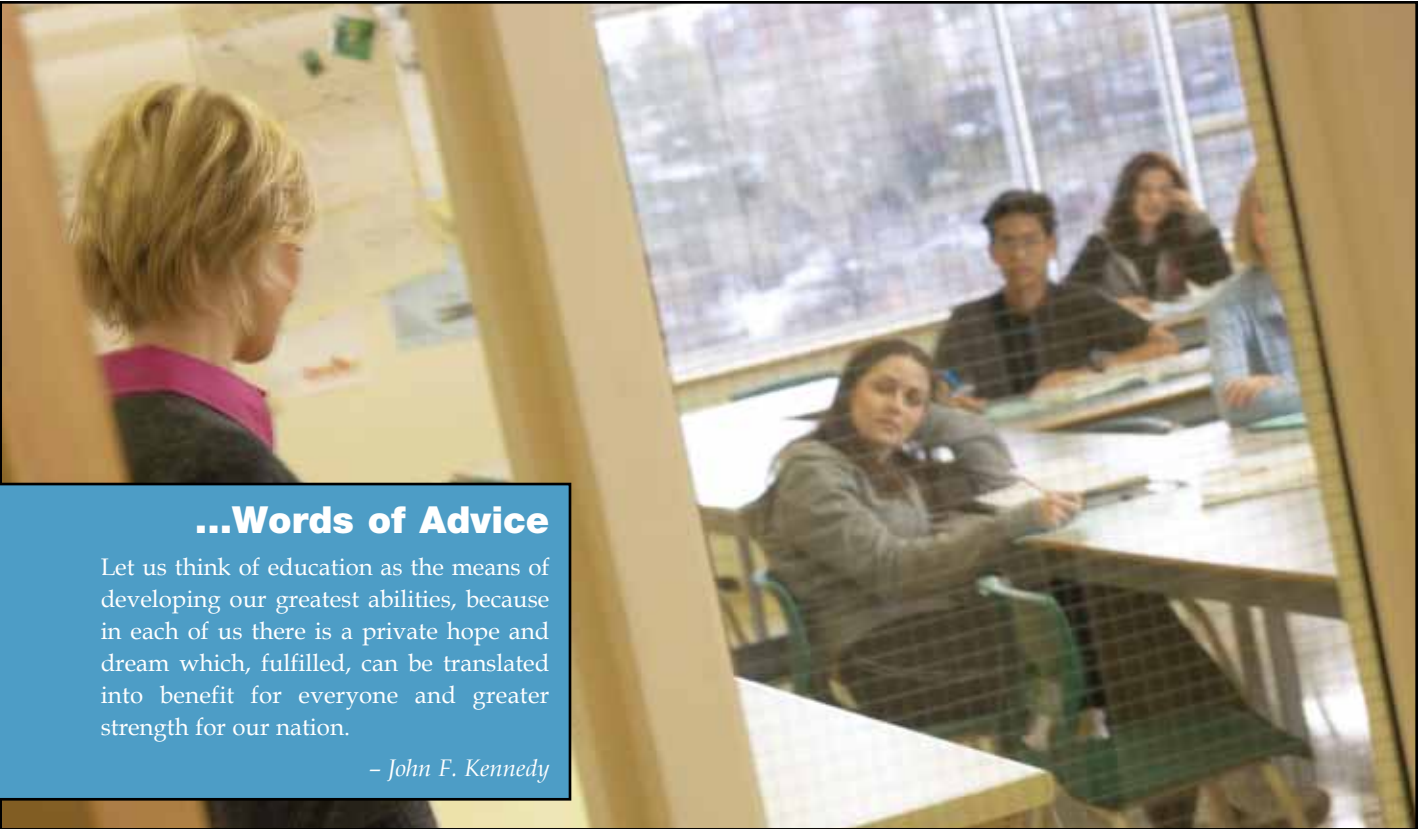
schools. The Best Buys report relies on participation rates in the federal free/reduced lunch program, a rate that is calculated annually and is used commonly as a proxy for measuring adverse student demographics.

Total Revenues Per Student (FY 2008)

Total revenues per student are calculated at a district level by dividing total revenues by the 2008-2009 ADM (average daily membership – aka student count). While we would prefer to focus on expenditures rather than revenues, as was done in previous Best Buy reports, some school districts have noted that the fund accounting procedures for Department of Education expenditure reports result in double counting of dollars that are transferred between funds. Therefore, in response to those concerns and in order to provide a more accurate and consistent benchmark, our analysis focuses on total revenues.

Standardization and Computation of Quality Index Data

The data for each factor have been standardized to create a combined quality index for each school. The data were standardized by converting each performance measure to a multiple of that factor’s standard deviation from the state mean. Each standardized measure was then multiplied times a specified weight to produce a total quality index for each school.

Best Buy schools are those schools that give taxpayers the best educational outcomes for their money. There are two methods by which a school can become a Best Buy. The school was named a Best Buy if it had a quality index above the state median of .0719 and total revenues below the statewide median of \$10,179 per student. The second method by which high schools could qualify was by having a quality index percentile ranking that was 20% higher than their percentile ranking for per student revenues. All high schools in the state were ranked from the highest quality index (#1) to the lowest quality index (#357). The schools also were ranked from the highest revenues per student (#1) to the lowest revenues per student (#357). The 20% variance method recognizes those schools that have above median revenues but are producing extraordinary academic outcomes. Additionally, schools with extremely low revenues could qualify as a Best Buy even if their quality index is slightly below the state median. **This year there are 135 Best Buy high schools.**

Honor Roll

Honor Roll schools have achieved academically in spite of higher percentages of students living at or near poverty levels. From the list of Best Buy high schools, Honor Roll schools are identified based on student income levels, as determined by participation in the federal free/reduced lunch program. These schools not only excel academically relative to their funding levels, but also have participation in the federal free/reduced lunch program that is above the statewide median of 31.2%. **This year, there are 26 Honor Roll schools (denoted in bold).**

The Best of The Best

The top five schools from the Best Buys list and the top five schools from the Honor Roll list were selected to represent this year's Head of the Class. The top five Best Buys are recognized because they demonstrated the greatest variances between the quality index and the revenues per student.
